The acquittal process allows us to make informed decisions for future funding opportunities. We ask that you submit an application only if you are confident that you will be able to successfully acquit the funds.

Please note that while we strive to support as many worthy projects as possible, our resources are limited. It is therefore not possible to support all funding applications.
